**NARRATIVE**

About 7:00 PM, on Friday, December 10, 2021, Officer Aldridge in the B455F responded to a radio call for an Investigate Motor Vehicle at 145 Cedar Street, Roxbury.

The CAD notes read as follows:

12/10/21 18:58:35 (pct07):CALLER STATES THERE IS A FRATERNITY AT ABOVE...STATES THAT A GROUP OF 15-16 STUDENTS GOT INTO A U-HAUL TRUCK BLIND-FOLDED...VEHICLE WENT DOWN CEDAR ST TOWARDS WASHINGTON ST... CALLER SAID HE HAD A VIDEO OF THE INCIDENT IF POLICE WANT TO SEE IT

Upon arrival, Officer Aldridge spoke to the reporting party, identified as Terrence Dilworth. Dilworth stated he lives at 153/155 Cedar Street. Dilworth stated he had surveillance videos on his house and had captured video of an U-Haul box truck in the driveway at 145 Cedar Street. Dilworth stated that a Northeastern University Fraternity (Phi Delta Theta) resides at 145 Cedar Street.

Dilworth stated at approximately 6:45 PM, unknown fraternity brothers had lead approximately 16 unknown male individuals, who were blindfolded, and lead them into the back of the U-Haul box truck. Dilworth stated that the unknown fraternity brothers shut the rear bay door of the U-Haul box truck, and the truck left the house and took a left onto Cedar Street towards Washington Street.

Dilworth showed the video to Officer Aldridge, which depicted approximately 16 unknown blindfolded individuals being lead to the back of the U-Haul. The unknown fraternity brothers had the unknown individuals enter the back of the U-Haul truck then shutting the bay door and leaving the scene.

Officer Aldridge went to 145 Cedar Street and knocked on the door. Two individuals, identified as [REDACTED] and [REDACTED] answered the door. [REDACTED] and [REDACTED] stated that their Fraternity, Phi Delta Theta, was conducting an initiation night with their pledges. [REDACTED] and [REDACTED] stated that the U-Haul was driving aimlessly on Fort Hill until all of their Fraternity brothers had arrived for the initiation. Officer Aldridge requested [REDACTED] and [REDACTED] to have the U-Haul truck return so a well-being check could be conducted. [REDACTED] and [REDACTED] stated they did not know why Boston Police responded and stated that this initiation was harmless. Officer Aldridge explained the reason for the call and how an individual could easily be injured in the rear of the U-Haul truck. [REDACTED] agreed to call the unknown fraternity brother to have them return to 145 Cedar Street. While [REDACTED] was making the call, [REDACTED] continued to question why an Officer was called and stated that other fraternities do "much worse" initiations.

[REDACTED] stated that the truck was around the corner and would be returning soon. [REDACTED] entered the residence to call the unknown fraternity brother to get an estimated time that the U-Haul would return. [REDACTED] stated that the U-Haul was returned to U-Haul and that the unknown pledges and fraternity brothers would return to 145 Cedar Street in approximately 30-45 minutes. Officer Aldridge inquired where the U-Haul was returned and [REDACTED] stated it was returned in Needham.

Officer Aldridge requested a Patrol Sergeant and Sergeant Casallas (C902) responded. Sergeant Casallas requested to speak to all residents of the apartment, and to have them come outside so he could speak to them. [REDACTED] and two other residents, identified as [REDACTED] and [REDACTED], came outside. Sergeant Casallas explained the dangers of this initiation and requested [REDACTED] or [REDACTED] to facetime the unknown brothers and pledges so their well-being could be confirmed. [REDACTED] placed a call to an unknown fraternity brother and requested to Facetime him. The unknown fraternity brother agreed and [REDACTED] Facetimed him. Sergeant Casallas requested to speak to the the unknown pledges. The unknown fraternity brother stated that there were 21 pledges who had been inside the rear of the U-Haul box truck. The unknown fraternity brother gave the phone to an unknown pledge who stated to Sergeant Casallas that all of the pledges were in good health, were uninjured, and were in Needham. The unknown pledge stated that they were getting a Lyft or an Uber back to 145 Cedar Street. Sergeant Casallas reiterated to [REDACTED] and [REDACTED] the dangers of this initiation and that a report would be generated.
